**ARTICLES OF DISSOLUTION OF

**ARTICLE I**  
**Name**

The name of the corporation is American Impressionist Society, Inc., a Florida not for profit corporation.

**ARTICLE II**  
**Adoption of Dissolution**

The corporation has no members who are entitled to vote on any matters within the corporation. The Board of Directors has adopted a resolution to dissolve this corporation.
