ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be:

Jo Anna Worthington Ministries, Inc.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE(S)

The specific purpose

The purpose for which this corporation is organized is exclusively for religious activities as is defined under the Internal Revenue Code, section 501(C); to promote Christ and Christian ethics and purposed of a Prayer Ministry of healing based on the gospel of Luke 4:18,19, and to do all such things as are lawful to further such purposes. No part of the net earnings of this corporation shall inure to the benefit of any private member or individual. No substantial part of the activities of this corporation are for the purposes of propagandizing or otherwise attempting to influence legislation and this corporation shall not participate or intervene in a political campaign on behalf of a candidate for public office. Upon dissolution, the assets of this corporation will not be distributed to its members or shareholders.

ARTICLE IV MANNER OF ELECTION OF DIRECTORS

The Board of Directors shall be composed of not less than three nor more than twelve persons appointed by the President and to be reviewed annually for reappointment or appointment of new candidates recommended by current board members. An initial organizational meeting was held November 10, 1999, and Jo Anna Worthington, 577 Compton Court, DeLand, FL, 32724 is President. H. Roumel Brown, 1313 North Alabama Ave., DeLand, FL 32724, is Vice-President-Secretary. John Brim, 2425 South Volusia Ave., Orange City, FL, 32763 is Treasurer.
