**ARTICLES OF INCORPORATION
OF

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

**ARTICLE I
NAME AND ADDRESS**

The name of this corporation shall be is the **Miami Music Authority, Inc.**, (the "Corporation"). The principal place of business and mailing address of this corporation shall be:

**ARTICLE II
DURATION**

The Corporation shall commence its existence with the filing of the Articles. The existence of the Corporation shall be perpetual, unless dissolved according to law.

**ARTICLE III
GENERAL PURPOSES**

The general purposes for which the corporation is organized are:

1. Unite South Florida's music scene: To facilitate the cumbersome process of networking and to disseminate all of the necessary information and resources so as to maintain the entertainment business in South Florida.
2. Education: Assist in promoting music and the arts in South Florida schools through contests, music programs, and workshops. Moreover, to hold technical training seminars on the mechanics of machines and tools used in the industry.
3. Events and Promotions: In the spirit of bringing creative and business professionals together, we want to facilitate the process of networking through social gatherings and events.

ARTICLE IV

The membership of the Corporation (the “Members”) shall consist of those persons who are associated within the South Florida music and entertainment community. A majority of all of the members of the Board of Directors of the Corporation (the “Board”) shall determine the manner of admission of the Members into the Corporation.

ARTICLE V
BOARD OF DIRECTORS

The power of the Corporation shall be exercised by or under the authority of, and the business and affairs of the Corporation shall be managed under the direction of, the Board, which shall initially have (5) directors. A majority of all of the members of the Board may from time to time increase or decrease the number of directors which shall never be less than three (3). ARTICLE X
EXEMPT STATUS

Notwithstanding any other provision of the Articles, this Corporation shall not carry on other activities not permitted to be carried on by an organization exempt from federal income tax under Section 501(c)(6) of the Internal Revenue Service Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

ARTICLE X1
DISSOLUTION

In the event of the dissolution of the Corporation and after all of the Corporation's liabilities and obligations have been paid and discharged, any residual assets of the Corporation shall be donated to one or more exempt organizations, qualifying as such under Section 501(c)(6) of the Internal Revenue Code of 1986, as amended, or the corresponding provisions of any prior or future law enforced by the United States Internal Revenue Service.
