KNOW ALL MEN BY THESE PRESENTS: That the undersigned person, acting as incorporator of a corporation under the Florida Not For Profit Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I - NAME

The name of the corporation shall be CHILDREN'S DESTINY, INC..

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be 4801 S. University Drive, Suite 308W, Davie, Florida 33328.

ARTICLE III - PURPOSE(S)

The purpose of this corporation is to produce and sell a documentary film dealing with the adverse impact of drug abuse on children and their families and to use the proceeds generated therefrom to support families and victims who have suffered from drug abuse as well as other suitable nonprofit endeavors.

ARTICLE IV - MANNER OF ELECTION OF DIRECTORS

The initial directors shall be appointed by the incorporator, Thomas C. Correa, who shall also serve as director. Thereafter, the method of election of directors shall be stated in

the bylaws.

ARTICLE V - INITIAL REGISTERED AGENT AND STREET ADDRESS


