Pursuant to the provisions of Section 617.1002 of the Florida Not-For-Profit Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

**Article 1 - Name of Corporation**


The name of the corporation shall be known as **WEST SHORE COMMUNITY CHURCH, INC.** rather than WESTSHORE COMMUNITY CHURCH, INC. Specifically, Article 1 of the originally filed Articles of Incorporation filed on November 23, 1999, shall be amended to that extent only. The mailing address for the corporation shall remain as originally filed, which is 310 N.W. Orange Drive, Port Charlotte, Florida 33952. Also, any other reference to the name of the corporation in said originally filed Articles of Incorporation and Certificate of Designation of Registered Agent is hereby amended. The date of adoption of the amendment was December 16, 1999, and the number of votes cast for the amendment was sufficient for approval. The amendment was adopted by the members.


**Article 2 - Balance of Articles**

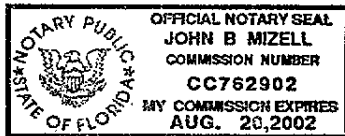
