# ARTICLES OF INCORPORATION OF MIRASOL HOMEOWNERS ASSOCIATION, INC.

Pursuant to Section 617.01201, Florida Statutes, these Articles of Incorporation are created by Jack J. Sterling, 2405 Piper Blvd., Naples, FL 34110, as sole incorporator, for the purposes set forth below.

### **ARTICLE 1**

NAME: The name of the corporation is MIRASOL Homeowners Association, Inc. (The Association)

#### **ARTICLE II**

**PRINCIPAL OFFICE:** The principal office of the corporation shall initially be located at 2405 Piper Blvd., Naples, FL, and subsequently at such other location as shall be determined by the Board of Directors.

### **ARTICLE III**

<u>PURPOSE AND POWERS:</u> The purpose for which the Association organized is to provide a corporate entity to act as a residential homeowners association under Sections 617-301-617312, Florida Statutes (1997) for the operation of a Residential Planned Community, located in Collier County, Florida.

The Association is organized and shall exist upon a non-stock basis as a Florida not for profit, and no portion of any earnings of the Association shall be distributed or inure to the private benefit of any Member, Director, or officer of the Association.

#### **ARTICLE IV**

**DIRECTORS AND OFFICERS** The affairs of the Association will be administered by a Board of Directors consisting of the number of Directors determined by the Bylaws, but not less than three (3) Directors, and in the absence of such determination shall consist of three (3) Directors.

Directors of the Association shall be elected by the members in the manner described in the Bylaws. Directors may be removed and vacancies on the Board of Directors shall be filled in the manner provided in the Bylaws.

The business of the Association shall be conducted by the officers designated in the Bylaws. The officers shall be elected by the Board of Directors at its first meeting following the annual meeting of the members of the Association and shall serve at the pleasure of the Board.

### ARTICLE V

AMENDMENTS: Amendments to these Articles shall be proposed and adopted in the following manner:

Proposal. Amendments to these Articles may be proposed by a majority of the Directors or by written petition of at least ten percent (10%) of the voting interests, and shall be submitted to a vote of the members not later than the next annual meeting for which proper notice can be given.

Vote Required. Except as otherwise required by Florida law, a proposed amendment to these Articles of Incorporation shall be adopted if it is approved by a majority of the voting interests at any annual or special meeting, provided that notice of any proposed amendment has been given to the members of the Association, and that the notice contains the text of the proposed amendment.

Effective Date. An amendment shall become effective upon filing with the Secretary of State and recording a certified copy in the Public Records of the County. The amendment must be recorded with the same formalities as required in the Bylaws for an amendment to the Bylaws.
