## ARTICLES OF INCORPORATION OF TRUTH & RESTORATION MINISTRIES, INC.

I, the undersigned natural person of the age of eighteen (18) years or more, acting as Incorporator of the corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation for such corporation.

I.

The name of the corporation is TRUTH & RESTORATION MINISTRIES, INC.

П.

The place in this state where the principal office of the corporation is to be is the City of Tanipa, County of Hillsborough in the State of Florida. The corporation may have such other offices, as may from time to time be designated by its board of directors.

Ш.

Said corporation is organized exclusively for charitable, religious and educational purposes, including, for such purposes, the conducting of community renewal programs, the conducting of religious worship, the purchase and development of real property, the printing and distribution of books and like material and the making of distributions to organizations that quality as exempt organizations under section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

In particular, the said corporation is a church, for the purposes of carrying out such services and functions that are normally carried out by a Christian church.

IV.

The number of directors constituting the initial board of directors of the corporation is THREE (3) and the names and addresses of the person who are to serve as the initial directors are:

Adams Street Tampa, FL 33611 No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, its members, trustees, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Three hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

Notwithstanding any other provision of these articles, this corporation shall not, except to insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

#### VI.

Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational or religious purposes as shall at the time qualify as an exempt organization or organizations under section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law), as the Board of Directors shall determine.

Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

#### VII.

The street address of the initial registered office of the corporation 8803 Auburn Way, Tampa, FL 33615, in the county of Hillsborough, and the name of the initial registered agent at such address is Carlos Marquez who agrees to act as such registered agent.

VIII.

- The corporation is a non-profit, no stock corporation.
- Membership is as defined in the By-laws.

IX.

The period of its duration is perpetual.

X.

To further the above purpose, the corporation shall have full power to purchase, lease or otherwise acquire property, to publish a newspaper, magazine, books, video materials, audio tapes and like means of communication, to own and/or operate radio or television stations, support missionaries and charitable endeavors, raise funds, and to do those things necessary to promulgate the purposes of the organization in an effective and an efficient manner.
