## ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

- Article I: The name of the corporation shall be: Eva Ministries Incorporated.
- Article II: The effective date of the corporation is to be January 1, 2000.
- Article III: The mailing address of Eva Ministries Incorporated is:  
P.O. Box 953999 Lake Mary, Florida 32746-9998. The principal place of business shall be: 1325 Chestwood Cove, Heathrow, FL 32746
- Article IV: The purpose of the corporation is:
- Establishing and supporting orphanages, prison ministries, churches as well as other established ministries in the United States and throughout the world with food, clothing and medical supplies.
  - Creating t.v. and radio broadcast promotions of conferences and special meetings also raising support for humanitarian aid, for hospitals, orphanages, churches and prisons.
  - Writing, self publishing books, and distributing brochures and pamphlets for the aid and understanding of the of the gospel of Jesus Christ throughout the United States and the world.
  - Purchasing a home that can be used for a residence and retreat home for missionaries to stay at when they come off the mission field. The house would also be used for leaders and other ministers to come and stay for a time of relaxation .
  - Mission trips: Traveling throughout the United States and the world preaching the gospel of Jesus Christ, and assisting in humanitarian aid anyway possible. Supporting and establishing halfway houses and other support systems for people coming out of prisons.
- Article V The manner in which the directors hold office will be by appointment of the president initially, thereafter elected by majority vote every two years
