ARTICLES OF INCORPORATION OF
ALL SAINTS, INDEPENDENT OLD CATHOLIC CHURCH, Incorporated
A FLORIDA NON-PROFIT CORPORATION

ARTICLE 1, Name. The name of the Corporation is All Saints
Independent Old Caatholic Chruch, Incorporated

Article 2, Duration. The durations of the Corporation is
perpetual.

Article 3, Purpose. The purpose of the Corporation is as
follows:-

A) The corporation is a not for profit corporation organized
under Chapter 617, Florida Statutes. It is not organized for
private gain. The specific purpose of this organization is the
preaching of the Gospel, the salvation of souls, and any other
related religious, charitable, ecclesiastical, or other function
performed by churches and or religious denominations that is
legal, and to conduct any legal business that a not for profit
corporation may engage in..

B) To exercise all rights and powers coffered by the laws of the
State of Florida Upon non profit corporations.

C) Provided However the corporation shall not , as required by
the IRS engage in or carry on propaganda or influence
legislation.

D) Provided , however, that the corporation shall not engage in
any action which is not permitted to be carried on by nonprofit
corporations under the Internal Revenue Code and no part of the
net earnings of the Corporation shall inure to the benefit of or
be distributed to its members, directors, or officers, but the
Corporation shall be authorized and empower to pay reasonable
compensation to these people for services rendered and to make
payments and distributions in furtherance of its stated purposes.

Article 4. Members. The Corporation shall have two classes of
members. Voting Members shall be the ordained Old Catholic Clergy
assigned to the Corporation. Non voting members shall be all non
ordained (lay) members. Voting members shall be designated as
such, and may be removed, by either the Prime Bishop or the
Supervising Archbishop. Non voting members shall be admitted and
removed by majority vote of the voting members. Voting members
and non voting members shall have such rights and privileges as
set fort in the Bylaws. voting members shall be entitled to one
vote. Non voting members shall not have the right to vote. The
