



Addition to ARTICLE IV MANNER OF ELECTION OF DIRECTORS

This verbiage is added to the original Articles of Incorporation and hereby becomes a permanent part thereof as requested by the State of Florida under Section 617.0202(d), Florida Statutes.

The Board of Directors of the Corporation shall consist of the four (4) Officers . The Officers of the Corporation shall be a President, Vice President, Secretary & Treasurer. The Officers shall be elected annually at the Annual Meeting which will be held at the end of March. Officers may be elected to a succeeding term, but thereafter must wait one year before holding said office again. Candidates for office will be nominated from the floor. Voting will be done by show of hands by the membership for each office at the duly called Annual Meeting at which a quorum of the membership is in attendance. Officers will be elected by a majority vote of those members in attendance at the Annual Meeting.
