ARTICLE FIVE

OFFICES AND TRUSTEES

The affairs of the Corporation are to be managed by a Board of Trustees. These Articles of Incorporation may be amended by the act of the Members of the Corporation. Such amendments may be proposed and adopted in the manner provided in the Bylaws of the Corporation.
