**ARTICLES OF INCORPORATION  
OF  
PEOPLE FOR PARKS, INC.**

*The undersigned incorporators, for the purpose of forming a corporation under the Florida  
Not for Profit Corporation Act, hereby adopt the following Articles of Incorporation:*

**ARTICLE I. NAME**

The name of the corporation shall be: PEOPLE FOR PARKS, INC.

**ARTICLE II. PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be:

510 So. 10<sup>th</sup> Street, Fernandina Beach, FL 32034

**ARTICLE III. PURPOSE**

The object and purpose of the Corporation shall be to work in conjunction with the City of Fernandina Beach, Florida, and specifically with the Parks and Recreation Department, in providing recreation services for the citizens of the community. The Corporation shall work to provide parks, equipment, maintenance, upkeep, and services to the public and shall accept donations to be used to fund these activities which provide recreational services to the citizens of Fernandina Beach, Florida.

In addition to the above, the purposes for which the Corporation is organized are exclusively charitable, and educational within the meaning of Section 501 (c) (3) of the Internal Revenue Code, or the corresponding provision of any future United States Internal Revenue Law.
