The undersigned, acting as incorporator of a Corporation pursuant to Chapter 617, Florida Statutes, adopts the following Article of Incorporation of such corporation:

ARTICLE I

The name of the Corporation Shall be SPIRIT & TRUTH WORSHIP CENTER, INC. The principal place of business of this corporation shall be 8302 Hibiscus Road, Fort Pierce, Florida 34951.

ARTICLE II

The period of the duration of this corporation is perpetual unless dissolved according to law.

ARTICLE III

The purpose for which the corporation is organized is: The corporation is organized for religious purposes and is to be operated exclusively for such religious purposes as will qualify it as an exempt organization under Section 501(c)(3) of the Internal Revenue Code.

ARTICLE IV

The qualifications for members and the manner of their admission are as provided for in the Bylaws of the Corporation.
