ARTICLES OF INCORPORATION
OF

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I

The corporation shall be named Zion Temple of the Apostolic Faith, Inc.

ARTICLE II

The principal place of business and mailing address of this corporation shall be: 1215 Seminola Boulevard, #105, Casselberry, Florida 32718.

ARTICLE III

The purposes of the corporation are religious and educational. The corporation shall engage in lawful activities as stated in F.S. 617.0301, in the broadest sense of the term, including, but not limited to fund-raising. The corporation shall engage in religious activities through media, such as television, radio and other forms of communication to the public, as well as provide books, tapes, videos, etc., for the benefit of the public. In addition, the corporation shall engage in non-profit endeavors such as Daycare Schools, Trade Schools, Rehabilitation programs and provide living facilities for senior citizens.

ARTICLE IV

The directors of the corporation shall be appointed by the President and ratified by the Board of Directors.

ARTICLE VII

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered by its employees and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof.

ARTICLE VIII

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501©3 of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to a state or local government for a public purpose.
