The name of the Corporation shall be **Operation Hope of Greater Florida, Inc.**

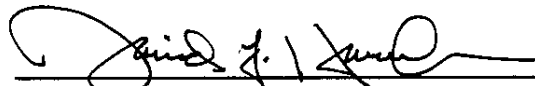
