ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not-for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

<u>ARTICLE I NAME</u>

ARTICLE III PURPOSE(S)

The specific purpose(s) for which the corporation is organized is(are):

The mission of New Hope Ministry of Salvation Church, Inc., is to reach out, encourage, and give NEW HOPE to the un-crowd of the surrounding communities and beyond; the un-saved, the un-churched and the un-happy using an evangelistic approach. <u>ARTICLE IV MANNER OF ELECTION OF DIRECTORS</u>

The manner in which the directors are elected or appointed is:

The directors are nominated by the church council, with a majority vote, at monthly meeting.

<u>ARTICLE V INITIAL REGISTERED AGENT AND STREET ADDRESS</u>

ARTICLE VII. COMMITTEES

The church shall elect such committees, as the church deems necessary. Committee members must be members of the church.

ARTICLE VIII. CHURCH COUNCIL

A council shall consist of all elected church staff members, the chairperson of the deacons, the directors of all program organizations, and the chairperson of all church committees. The pastor shall serve as chairperson of the church council. The church council serves as the administrative body of the church and shall meet every Tuesday of each month and coordinate the work of the church.

ARTICLE IX. AMENDMENTS

The bylaws may be revised by a majority vote of the membership of the church body present at the time of the business meeting.

ARTICLE X. CHURCH FACILITIES USAGE

The facilities of New Hope Ministry of Salvation Church, Inc. extend all rights to members of this church for personal facility usage. Community members also have the rights to request usage of the facilities for weddings, funerals or etc.... And for various purposes. The purposes must be approved by the church council and must not infringe on the beliefs or the church, bylaws and standards that are set by the word of God. This also states that members or community members will permit NO SECULAR MUSIC OR ATTIRE (under any circumstances) in the church facility for any special purpose.

There is no fee for members for the usage of the facilities. Non-members (community members) must adhere to a fee that is set by the church council at the time of the meeting for the purpose.

Each request must be submitted in writing, including purpose, date, time and contact person in charge of the function. A letter of acceptance or denial will be submitted to the person in charge as soon as the church council has come to an agreement.

Appeals to the church council ruling must be submitted within (5) five days in writing, for review. At that time the board will re-convene and listen to a verbal statement of why this church council should permit the usage of the facilities.

XI. DISSOLUTION

The purpose of which the New Hope Ministry of Salvation Church, Inc., is organized excessively religious, charitable, scientific, literary, and educational within the means of Section 501 ©(3) of the Internal Revenue code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to carried on by and organization exempt from Federal Income Tax under Section 501 $\mathbb{O}(3)$ of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501©(3) of the Internal Revenue Code, or corresponding Section of any future Federal Tax Code, or shall be distributed to the Federal Government, or a State or Local government for public usage. Any such assets not so disposed of shall be disposed of by the court of common Pleas of the county in which the principal officer of the corporation is then located, exclusively for such purposes or to such organization as the Pensacola Baptist Bay Association or Southern Baptist Association Convention. as said court shall determine, which are organized and operated exclusively for such purposes.

Be it advised that the bylaws of the New Hope Ministry of Salvation Church, Inc.; were voted and agreed upon to be the true bylaws of the stated church. Witnessed by the church council on the 26th day of August, 1999 at the business meeting:
