ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be: **The Rock, A Pentecostal Family Worship Center, Inc.**

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III PURPOSE

The specific purpose for which the corporation is organized is: To operate as a church while serving the local community with spiritual leadership. We intend to feed the hungry, supply basic needs to the less fortunate and to give any assistance necessary in our community.

ARTICLE IV MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is: Initially by appointment by the chairman of the board, subsequently by nomination of the board of directors, a vote consisting of a 2/3 majority (66%) with the final vote from the chairman of the board.
