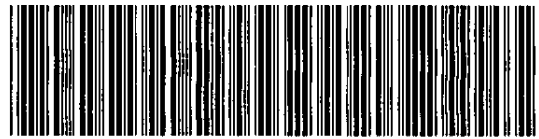

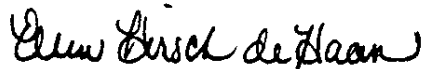

AMENDMENTS TO  
ARTICLES OF INCORPORATION OF  
TAMPA BAY COMMUNITY ASSOCIATION, INC.

1. Amendment to Article V, Section 5.01 of the Articles of Incorporation, to read as follows:

5.1 The affairs of the COMMUNITY ASSOCIATION shall be managed by a BOARD consisting of not less than three (3) directors, ~~and which shall always be an odd number.~~ The number of directors shall be determined in accordance with the BYLAWS. In the absence of such determination, there shall be three (3) directors so long as DECLARANT has the right to appoint any director, ~~and thereafter there shall be seven (7) directors.~~

2. Amendment to delete Article V, Section 5.2 of the Articles of Incorporation in its entirety, as follows:

5.2 The directors of the COMMUNITY ASSOCIATION shall be elected ~~by the OWNERS~~ as provided in the BYLAWS, except that DECLARANT shall have the right to appoint the directors of the COMMUNITY ASSOCIATION as follows: . . .

3. Amendment to Article IX, Section 9.3 of the Articles of Incorporation, to read as follows:

9.3 At such meeting, a vote of the OWNERS entitled to vote thereon shall be taken on the proposed amendment. The proposed amendment shall be adopted upon receiving the affirmative vote of a majority two-thirds (2/3) of the votes of ~~the entire membership voting cast~~ in person or by proxy at a meeting of the COMMUNITY ASSOCIATION at which a quorum is present.
