## **Articles Of Incorporation**

*The undersigned, acting as incorporator(s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:*

### **Article I - Name**

The name of this Corporation shall be Deliverance Gospel Temple Worship Center, Inc. The principle place of business of the Corporation shall be 1101 North Main Street, Gainesville, Florida 32601. The corporation is pursuant to the Florida Nonprofit Corporation Code.

### **Article II - Duration**

The duration of this corporation shall be perpetual, unless the board of directors, votes to terminate the corporation by unanimous decision.

### **Article III - Purpose**

1. Under the Florida Non-Profit Corporation Code and is exclusively for religious purposes within in the meaning of section 501(c)(3) of the Internal Revenue Code of 1954.
2. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to carry on (1) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code of 1954 or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1954.
3. To provide a place of worship based on the christian faith and to teach the word of God to those that desire to become a christian and those that are practicing the Christian faith.
4. To spread the Gospel of Jesus Christ throughout much of the world as is possible. The corporation will engage in teaching, baptizing and leading disciples into the Body of Christ.
5. To provide a place of refuge for the homeless, abused, sick and poor.
6. To produce and provide all necessary physical facility and resources for the Corporation and church and administer such property facility and resources for the church.
7. To purchase, acquire, lease, sell and dispose of property both real and personal and to encumber, pledge, mortgage, lease and other deals in the same at pleasure, to the same extent as a natural person can do.

8. To make and execute deeds, mortgages, releases, and instruments of indebtedness, negotiable or nonnegotiable and to enter into and execute contracts of every kind and character with any persons, firm or corporation.

#### **Article- IV Director Election**

The manner in which the directors are elected or appointed are as follows:

1. The Pastor of the Corporation shall remain in office as long as the Divine Call of God is upon her. The Pastor is appointed as President of the Corporation. Other directors shall be appointed as needed.


2. The Pastor of the Corporation shall be responsible for managing the affairs of the Corporation. By-laws of the corporation shall be made by the Pastor with assistance, when needed, of the board members. Board members shall consist of persons appointed from the membership at the discretion of the Pastor. Proposed by-laws shall be altered, rescinded or voted into law by the majority vote of those members present at any such called business meeting concerning by-laws.

3. Amendments to the Articles of Incorporation may be proposed by the Pastor or any board member upon approval by the Pastor and adopted by the majority vote of board members at any such called business meeting concerning proposal or adoption of Articles of Incorporation.



### **Article- VIII Dissolution**

On the dissolution or winding up of the corporation, its assets remaining after payment of, or provision for payment of, all debts, and liabilities of this corporation, shall be distributed to a nonprofit fund, foundation, or corporation, which is organized and operated exclusively for religious, educational and charitable purposes under Section 501 (c)(3) of the Internal Revenue Code of 1954, or corresponding section of any future federal tax code, or shall be distributed to the federal, state or local government for a public purpose. Any such asset not disposed of shall be disposed of by Court of Common Pleas of the county in which the principal office of the organization is located, exclusive for such purposes or to such organization or organizations, as said Court shall determine which are organized and operated exclusively for such purposes.
