ARTICLES OF AMENDMENT TO THE AMENDED AND RESTATED ARTICLES OF INCORPORATION OF PCBC, INCORPORATED

THE UNDERSIGNED, Ronald M. Zychowski President of PCBC, INCORPORATED, a

Florida not-for-profit corporation (the "Corporation"), for and on behalf of the Corporation,

hereby executes these Articles of Amendment to the Articles of Incorporation of the

ARTICLE FIRST: The name of the Corporation is PCBC, INCORPORATE

ARTICLE SECOND: The first amendment to the Amended and Restated
Articles of Incorporation of the Corporation effected by these Articles of
