OF

A not-for-profit corporation

*The undersigned, acting as incorporator(s), of a corporation pursuant to
Chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation.*

ARTICLE I. CORPORATE NAME.

The name of this not-for-profit corporation is "Music Education Foundation of Northwest Florida, Incorporated", which for convenience is hereinafter referred to as MEFNF, Inc.

ARTICLE II. PRINCIPAL OFFICE.

The mailing address of this corporation shall be Music Education Foundation of Northwest Florida, Inc., 1815 West 15th Street, Suite 17, Panama City, Florida 32401.

ARTICLE III. PURPOSE.

MEFNF, Inc. is organized to foster quality vocal and instrumental music instruction, to promote music appreciation and literacy in the many styles of musical expression. MEFNF, Inc. will primarily accomplish these goals through funding (a) music school(s), teacher education, student and teacher workshops, and live performances. As a not-for profit corporation, the MEFNF, Inc. shall meet the

requirements of Internal Revenue Code § 501 (c)(3) of 1954, or the corresponding provision of any present or future tax law. In addition any provision of these Articles of Incorporation or of the By-laws of MEFNF, Inc. which violates said provision shall be null and void; noting, however, that said nullity shall not affect any other provision(s) of those said documents.

ARTICLE IV. BY-LAWS.

The initial By-laws shall be approved by a majority vote of the Incorporators, who shall also serve as the Incorporating Board of Directors. The power to adopt, alter, amend, or repeal By-laws shall be vested in the Board of Directors and the Members. By-laws adopted by the Members may be repealed or changed only by the Members' By-laws. By-laws adopted by the Board of Directors may be repealed or changed by the Board of Directors or by the Members.

ARTICLE V. MANNER OF ELECTION OF DIRECTORS.

The Incorporating Board shall initially appoint additional Board members as it deems necessary, not to exceed seven (7) Board members, which shall be referred to collectively as the Interim Board of Directors. At a time stated in the By-laws, the Interim Board of Directors shall be replaced by the Founding Board of Directors who shall be elected or appointed. Subsequently, a members meeting shall be held annually, at a time stated in the By-laws, for the election or appointment of the Board of Directors, who shall be elected or appointed as stated in the By-laws.

ARTICLE VI. LIMITATION OF CORPORATE POWERS.

The corporate powers of this corporation are as provided in § 617.0302 Florida Statutes; noting, however, that MEFNF, Inc. shall conform to the requirements of Internal Revenue Code § 501 (c)(3) of 1954, or the corresponding provision of any present or future tax law.

ARTICLE VII. INITIAL REGISTERED AGENT AND OFFICE.

The name and mailing address of the initial registered agent is Michael D. Reisman.

ARTICLE IX. MEMBERS.

- 1) **Qualifications.** Members of MEFNF, Inc. shall be granted to all persons and organizations that, by annual application and donation of funds, express interest in actively promoting MEFNF, Inc. purposes.
- 2) **Classes of Membership.** The Board of Directors shall classify members according to the amount of donation presented.
- 3) **Rights of Members.** Each member is entitled to vote at any member meeting and is eligible to hold office and serve on the Board of Directors.
- 4) **Organization Members.** The Board of Directors may define and prescribe rules and regulations for organizational membership to be granted to business, corporate, or similar entities. Such organization may exercise member rights by designating, in writing, an individual to act as member on behalf of the organization.

ARTICLE X. AMENDMENT.

These Articles of Incorporation may be amended in any manner and by way of any procedure provided by law, provided that at least 66% of the attending members vote in favor of the amendment at a meeting held in accordance with the By-laws.

ARTICLE XI. MISCELLANEOUS.

- 1) This corporation shall exist perpetually, commencing with the date of execution and acknowledgement of the Articles.

- 2) The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.
