ARTICLES OF INCORPORATION  
OF  
NEW LIFE CHURCH, INC.

ARTICLE I

The name of the corporation is NEW LIFE CHURCH, INC.,  
a not-for-profit corporation.

ARTICLE II

This corporation shall have perpetual existence.

ARTICLE III

This corporation is organized for the following  
purposes

1. To deal in all matters which are not for profit  
and which fully qualify for tax purposes for a non-  
profit corporation as specified in both federal and  
state laws.
2. To promote and disseminate the Gospel and  
related matters thereto as found in and based on both  
the Old and New Testaments of the Bible.
3. To operate and promote and perpetuate schools  
and other institutions for the purpose of promoting  
the Gospel as based on both the Old and New Testa-  
ments of the Bible.
4. To promote and disseminate and perpetuate any  
and all expressions and messages, verbally and by  
writings and by mass media, such as radio and tele-  
vision, necessary or implied as an assistance to said  
Gospel.
5. to promote and erect churches, in addition to  
educational institutions named above for the purposes  
of preaching and evangelizing the Gospel or matters  
incidental thereto which may be expressed or employed  
in either the Old and New Testaments of the Bible.
6. To assist and aid persons who are interested  
in the promotion and dissemination of the Gospel of  
both the Old and New Testaments, so long as such  
assistance is not for profit.

7. To promote and disseminate a religious culture which is consistent with the writings of both the Old and New Testaments of the Bible.

8. To acquire and administer funds and property which, after the payment of expenses, shall be devoted exclusively to historical, educational, literary, scientific, artistic, and cultural purposes.

9. Perform all other acts authorized by state and federal laws.

10. To make any of the purposes or matters herein consistent with religious institutions such as churches and schools in accordance with Florida law, as well as federal law, which govern religious matters found to be for a non-profit purpose.

11. The purposes for which the corporation is organized are exclusively religious, charitable, scientific, literary and educational within the meaning of Section 501(C)(3) of the Internal Revenue Code of 1986 or the corresponding provisions of any future United States Internal Revenue Law.

12. Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501(C)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Revenue law.

13. Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(C)(3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code, or shall be distributed to the Federal, State, or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes.

#### ARTICLE IV

The street address and principal office address of this corporation is 5900 Tippin Avenue, Pensacola, Florida 32504.

#### ARTICLE V

The initial registered agent of this corporation is Raymond E. Sunday, whose address is 1525 Enfinger Road, Milton, Florida 32571.

#### ARTICLE VI

The affairs of the corporation shall be managed by a Board of Directors consisting of not less than three (3) members. The method of election of directors shall be as determined by the by-laws of the corporation.

#### ARTICLE VII

The Board of Directors shall have the power to enact by-laws which may be altered, amended, or repealed, and new by-laws adopted only by the affirmative vote of a majority of the Board Members.

#### ARTICLE VIII

Amendments to the Articles of Incorporation shall only be approved by a majority of the members of the Board of Directors.

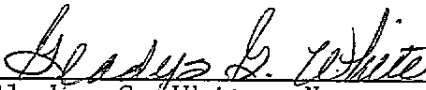
