

Pursuant to Sections 617.1002 and 617.1006 of the Florida Not for Profit Corporation Act, the Articles of Incorporation of The RITA Foundation, Inc. (the "Corporation"), are hereby amended according to these Articles of Amendment:

FIRST: The name of the Corporation is The RITA Foundation, Inc.

SECOND: Section A of Article IV of the Articles of Incorporation is amended in its entirety to read as follows:

A. The Corporation is organized and shall be operated exclusively for charitable, educational, and scientific purposes, including, but not limited to: (i) supporting breast cancer research, awareness, and related patient service programs, and (ii) making distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "Code"), and contributions to which are deductible under Section 170(c)(2), 2055(a) and 2522(a) of the Code, or the corresponding provisions of any future federal tax laws.
