ARTICLES OF INCORPORATION OF VEDIC CULTURAL SOCIETY

The undersigned Incorporator of these Articles of Incorporation, being a natural person, competent to contract pursuant to the provisions of chapter 617, Florida Statutes, for the purpose of establishing a non profit corporation under the laws of the State of Florida , does hereby declare the following:

Article I

The name of the society shall be Vedic Cultural Society, Inc.

Article II

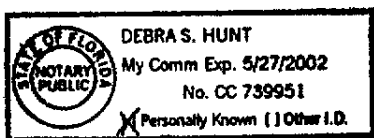

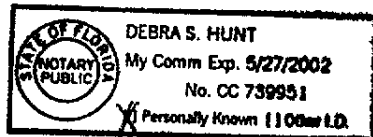
