**ARTICLES OF DISSOLUTION
OF

Pursuant to the provisions of Section 617.1401 of the Florida Statutes, the undersigned Florida corporation hereby adopts the following Articles of Dissolution:

ARTICLE I - NAME OF CORPORATION

The name of the corporation is VIERA EAST VILLAGE CENTER COMMERCIAL DISTRICT ASSOCIATION, INC. (hereinafter referred to as the "Corporation").

ARTICLE II - DATE OF FILING

The Corporation's Articles of Incorporation were filed with the Department of State on December 9, 1999.
