ARTICLES OF INCORPORATION
OF
TAMPA YOUTH BASKETBALL ORGANIZATION, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation shall be:

TAMPA YOUTH BASKETBALL ORGANIZATION, INC.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: Tampa Youth Basketball Organization, Inc., 5330 Black Pine Drive, Tampa, FL 33624.

These Articles of Incorporation may be amended by a majority vote of the Board of Directors.

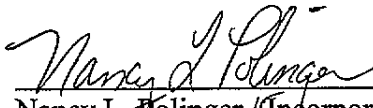

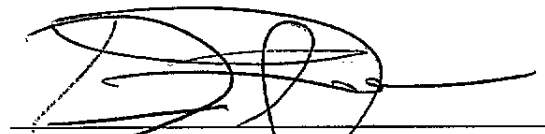
