Articles of Corporation
Of

Faith and Deliverance Full Gospel Church, Inc.

We, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation pursuant to Chapter 617.0202, F.S. Florida Statutes as amended of the laws of the State of Florida, applicable to corporations not for profit under the following proposed charter:

Article I

Name

The name of this corporation is Faith And Deliverance Full Gospel Church,
/ hereinafter referred to as "the corporation."

Article II

The principal office of the corporation will be located at 1836 20th Avenue
South, St, Petersburg, Florida 33712.

Article III

Purpose

The purpose shall be to establish and maintain an assembly of Christian fellowship and worship; to engender and foster among its members the tenants as it is practiced in the faith of the Faith And Deliverance Full Gospel Church; to teach close adherence to the principles of religion, education and charity; to acquire and maintain building or buildings for formal worship and for conduction church schools in Christian work and fellowship and as a permanent or temporary dwellings as rent homes or religious resorts for members and guests.

Article IV

Election of Officers

Election of officers will adhere to Roberts Rule of Order. However, exception can be made by unanimous vote of persons present.

1. Pastor

The election of pastor will consist of the Church Conference selection a search team or committee to bring back to the Church Conference or governing body three (3) names to be considered. With an independent (a qualified person not a member of said Church) presiding officer holding the election after two official announcements have been made public to the member congregation over a minimum period of two weeks (14 days) through the Church's weekly Bulletin. The person elected by secret ballot must receive a simple majority vote or 51%. The pastor is also the chief administrative officer.

2. Deacons and other major officers

The major officer such as deacons, deaconesses, superintendent of Church School, trustees, Church Secretary, Pianist, organist, etc. are recommended by the pastor and confirmed or rejected by simple majority vote (51%) by the Church Conference or governing body of the local Church after a minimum of one week (7 days) public announcement through the Church weekly bulletin.

Some minor offices such as committee chairpersons, director of evangelism, director of outreach, ministers charity etc. might be appointed by the pastor with the vote of the church governing body. All officers will be subject to re-election every two- (2) years but can serve indefinitely. The directors of the corporation shall be elected in conformity with the election of Deacons, trustees and other major officers of the church; the directors are subject to re-election every two- (2) years but can serve indefinitely.

Article V.

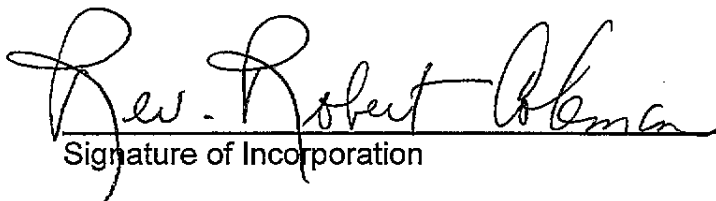
