ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I: NAME

The name of the corporation shall be: Seminole Alumni Foundation, Inc.

ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: Post Office Box 895, Tallahassee, Florida, 32302.

ARTICLE III: PURPOSE(S)

The purposes for which the corporation is organized are as follows:

- 1) To function in accordance with the specific objectives of and in conformity with the Constitution and Bylaws of the Grand Chapter of Sigma Pi Fraternity, International;
- 2) To assist, stimulate and cooperate with the active undergraduate chapter of Sigma Pi Fraternity at Florida State University, and those chapters within a reasonable radius of the Foundation, in the promotion of their general welfare and activities;
- 3) To provide opportunities for social, business and professional contacts and relations among members of the Foundation and alumni, in general, of Sigma Pi Fraternity; and
- 4) To purchase, own, rent, lease, mortgage and encumber real estate and personal property for the Chapter and Fraternity.

ARTICLE IV: MANNER OF ELECTION OF DIRECTORS

The manner in which Directors are elected are as noted in the corporation bylaws.

ARTICLE V: INITIAL REGISTERED AGENT AND STREET ADDRESS

The name of the initial registered agent at the registered office is David K. Foy. The street address of the initial registered agent is 1333 Airport Drive, #G-9, Tallahassee, Florida 32304.

ARTICLE VI: INCORPORATOR

The name and address of the Incorporator to these Articles of Incorporation is: David Foy, 1333 Airport Drive, #G-9, Tallahassee, FL 32304.

ARTICLE VII: EARNINGS AND ACTIVITIES

No part of the net earnings of the corporation shall inure to the benefit of, or be distributed to its members, trustees, directors, officers or other private person, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal Income Tax under Section 501 (c) (3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Code) or (b) by a corporation contribution to which are deductible under Section 170 (c) (2) of the Internal Revenue Code (or corresponding provision of any future United States Revenue Code).
