ARTICLES OF INCORPORATION
OF
Mattox Revival Center Ministries, Incorporated
A NON-PROFIT CORPORATION

The undersigned incorporators, in order to form a non-profit corporation under the laws of the State of Florida, hereby adopt the following Articles of Incorporation:

- I. The name of the corporation shall be Mattox Revival Center Ministries, Incorporated.
- II. The principle place of business and mailing address of this corporation shall be:

- III. The specific purposes for which this corporation is organized are religious and are limited to the following items:

- * to promote the Christian faith and adherence thereof as outlined in the Holy Bible;
- * to evangelize and to promote evangelism;
- * to give purpose, inspiration and to foster unity among Christians;
- * to participate in missionary activities and to promote missions;
- * to provide religious education through the publishing of newsletters in addition to other religious media including public speaking engagements and seminars;
- * to conduct a regular religious worship service through various forms of ministries;
- * to license and ordain qualified individuals for ministry;

This corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

- IV. The Initial Board of Trustee shall consist of the Incorporators of M.R.C.M. Subsequent trustees shall be elected in accordance with section 4.05 of the bylaws:

"Section 3.9 Nomination, Election and Removal

Nomination for Trusteeship may be made by a trustee at any meeting of the Board of Trustees provided that such nomination has been submitted previously to the President and placed on the official agenda of said meeting. Election of a Trustee may be made by two-thirds (2/3) majority vote of the Trustees present. A Trustee may be removed by a two-thirds (2/3) majority vote of the Trustees present."



VI. Any additional provisions for the operation of the corporation are as follows:

- A. Upon the dissolution of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall distribute all remaining assets to one or more nonprofit funds, foundations or corporations which are organized and operate exclusively for Christian religious purposes which have established its/their tax exempt status under Section 501(c)(3) of the Internal Revenue Code.
- B. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.
- C. No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these articles.
- D. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.
