ARTICLES OF INCORPORATION

We, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation not for profit under Chapter 617, Laws of the State of Florida, providing for the formation, liability, rights, privileges and immunities of a corporation not for profit.

ARTICLE I  
NAME OF CORPORATION

The name of this corporation shall be S/SGT. JOHN J. REDDY GOLD COAST CHAPTER 133 DISABLED AMERICAN VETERANS, INC.

ARTICLE II  
PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 921 Lyons #3101, Coconut Creek, Florida 33063.

ARTICLE III  
PURPOSE(S)

The specific purpose(s) for which this corporation is organized is (are): To uphold the Constitution and laws of the United States, to realize the true American interest and work for the betterment of all wounded, gassed, injured and disabled veterans, to cooperate with the U.S. Veterans Administration and all other public and private agencies devoted to the cause of improving and advancing the condition, health and interest of all wounded, gassed, injured and disabled veterans, to serve our comrades, our communities and our country and to encourage in all people that spirit of understanding in our country and to future wars. This corporation is limited to such as will qualify it as an exempt organization under Internal Revenue Code Section 501(c)(4). This corporation will not, as a substantial part of its activities, carry on propaganda or otherwise attempt to influence legislation. This corporation shall not participate in or intervene in any political campaign (including the publishing or distributing of statements) on behalf of any candidates for public office.

ARTICLE IV  
MANNER OF ELECTION OF DIRECTORS

The qualifications of members and their admission are in accordance with National Organization Bylaws. The corporation shall consist of every member in good standing or any person who shall become a member in good standing of S/Sgt. John J. Reddy Gold Coast Chapter #133, Disabled American Veterans, Inc., Department of Florida. Pursuant to Section 617.0202(d), Florida Statutes, the directors of this corporation are appointed or elected in accordance with the Bylaws of the National Organization and Chapter Bylaws in which a Commander, Sr. Vice Commander, and one or more Chapter Jr. Vice Commanders are appointed or elected, and shall elect or appoint an Adjutant and a Treasurer.

ARTICLE V  
NON-STOCK BASIS

This corporation is organized under a non-stock basis.

ARTICLE VI  
DISSOLUTION

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Section 501(c)(4) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future law, or to the Federal, State or Local Government for exclusive public purpose.
