# ARTICLES OF INCORPORATION OF S/SGT. JOHN J. REDDY GOLD COAST CHAPTER 133, DISABLED AMERICAN VETERANS, INC.



We, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation not for profit under Chapter 617, Laws of the State of Florida, providing for the formation, liability, rights, privileges and immunities of a corporation not for profit.

### ARTICLE I NAME OF CORPORATION

The name of this corporation shall be S/SGT. JOHN J. REDDY GOLD COAST CHAPTER 133 DISABLED AMERICAN VETERANS, INC.

### ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 921 Lyons #3101, Coconut Creek, Florida 33063.

### ARTICLE III PURPOSE(S)

The specific purpose(s) for which this corporation is organized is (are): To uphold the Constitution and laws of the United States, to realize the true American interest and work for the betterment of all wounded, gassed, injured and disabled veterans, to cooperate with the U.S. Veterans Administration and all other public and private agencies devoted to the cause of improving and advancing the condition, health and interest of all wounded, gassed, injured and disabled veterans, to serve our comrades, our communities and our country and to encourage in all people that spirit of understanding in our country and to future wars.
