## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF

PALM HARBOR UNIVERSITY HIGH SCHOOL HURRICANES SOCCER BOOSTERS, INC.

Pursuant to Florida Statute 617.1002 the Articles of Incorporation of Palm Harbor University High School Hurricanes Soccer Boosters, Inc. a not-for-profit corporation, are hereby amended as set forth below.

1. Article Three is hereby amended as follows:

Article Three: Purpose

Palm Harbor University High School Hurricanes Soccer Boosters, Inc. is a non-profit corporation and shall be operated exclusively for educational and charitable purposes within the meaning of Section 501 (c)(3) of the Internal Revenue code of 1986, or the corresponding section of any future Federal tax code.

2. Article Eight is hereby established as follows:

Article Eight: Dissolution

Upon termination or dissolution of the Palm Harbor University High School Hurricanes Soccer Boosters, Inc., any assets lawfully available for distribution shall be distributed to one or more qualifying organizations described in Section 501(c)(3) of the 1986 Internal Revenue Code (or described in any corresponding provision of any successor statute) which organization or organizations have a charitable purpose which, at least generally, includes a purpose similar to the terminating or dissolving corporation.

There are no members entitled to vote on these foregoing amendments. These amendments were adopted by the Board of Directors at a meeting on April 17, 2019.
