The undersigned Incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby forms a not for profit corporation under the laws of the State of Florida.

**ARTICLE I. CORPORATE NAME.**

The name of the corporation (the "Corporation") is:

**ARTICLE II. PURPOSES.**

The purposes for which the Corporation is formed are as follows:

- (a) To promote, sponsor, and campaign for a proposed amendment to the Charter of Miami-Dade County and to raise funds and gather signatures on petitions relative thereto; and
- (b) To exercise all powers that are or may hereafter be conferred upon corporations formed under Chapter 617 of the Florida Statutes, and to do any and all such other acts and things necessary, desirable or appropriate to carry out or accomplish any of the purposes of this Corporation.

**ARTICLE III. PRINCIPAL OFFICE AND MAILING ADDRESS.**

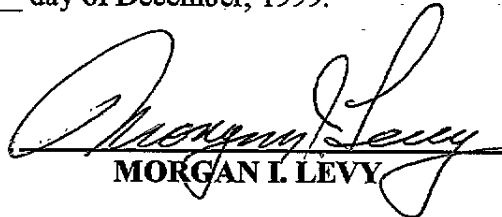
