ARTICLES OF INCORPORATION OF FAMILY INVOLVEMENT & COMMUNITY DEVELOPMENT

ARTICLE I. The name of the Corporation is Family Involvement & Community Development Center, Inc.

ARTICLE II. The principal place of business and mailing address of this corporation shall be: 2719 Country Club Drive, Apartment 35, Tallahassee Fl. 32301

ARTICLE III. The purpose of the corporation is as follows:

A. To create opportunities and to provide resources to the Southeast Community of Tallahassee, Florida, in education, business and economic development.

B. To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations.

C. Provided, however, that the corporation shall not engage in any action which is not in the best interest of the corporation, as determined by the Board of Directors. Net earnings of the corporation, derived from approved actions or otherwise, shall inure to the benefit or be distributable to its members, directors, or officers.

The manner of election of the directors are as stated in the bylaws.

ARTICLE IV: The Corporation shall have Voting Members, who shall be elected (and may be removed) by a majority of the Voting Members, and who shall have all the rights and privileges of members of the Corporation. The Bylaws will provide for Nonvoting Members of one or more committees, who will shall be admitted in such manner and who shall have such rights and privileges as are set forth in the Bylaws, but who shall not have the right to vote.
