hereby forms a religious corporation not for profit in accordance with the provisions of Chapter 617, Florida statues, and all amendments relating thereto and hereby adopts the following articles of incorporation:

**ARTICLE I**

**THE NAME AND ADDRESS**

The name of the corporation is, **CHRIST WORLD'S HOPE PENTECOSTAL CHURCH, INC.** with a physical address at 647 Rifle Range Rd., Wahneta, Fl. 33880.

**ARTICLE II**

**PURPOSE**

The purpose of this corporation shall be to operate and maintain an evangelistic ministry which is true to the Bible as the infallible Word of God and the only rule of faith and practice; which is Christian in doctrine, from and government; and which serves and gloffies Jesus Christ as Lord and Living Savior throughout all funtions of a Christian ministry in the broadest sense including but not limited to worship, education, discipleship, evangelism, fellowship, and loving care and service to and for its member and to a community which is as far and wide as it may effectively reach by whatever means.

**ARTICLE III**
