ARTICLES OF INCORPORATION

The undersigned incorporate, for the purpose of forming a corporation under the Florida Not for Profit Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I - NAME

The specific purpose for which the corporation is organized is:

Charity: Christian Philanthropic Organization.

To meet the spiritual, moral and material needs of sick children and teenagers (suffering from any kind of disease) in hospitals and related places – nationally and internationally – wherever this organization is planted or comes to act.

ARTICLE IV - MANNER OF ELECTION OF DIRECTORS
