ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the FLORIDA NOT FOR PROFIT ACT, hereby adopt(s) the following Articles of Incorporation

ARTICLE I: NAME

The name of the corporation shall be: **Forgotten Coast Builders Association, Inc.**

ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III: PURPOSE(S)

The specific purposes for which this corporation is organized are to the extent permitted by law:

- (A) To associate the builders within its jurisdiction for the purpose of mutual advantage and cooperation
- (B) To collaborate with all fields related to the building industry within the Association's jurisdiction for the benefit of the industry as a whole.
- (C) To assist in the accomplishment of the mutual objectives of "The National Association of Home Builders" of the United States and the "Florida Home Builders Association"
- (D) To operate without profit and no part of the income of the Association shall ensure to the benefit of any individual member

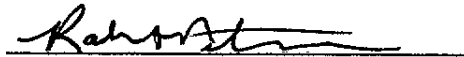
