

**ARTICLE I**

The name of the corporation is: SUNCOAST RELIGIOUS SCIENCE CHURCH,

INC.

**ARTICLE II**

The term of existence of the corporation is perpetual.

**ARTICLE III**

The address and principal office of the corporation is: P. O. Box 2366, Palm Harbor, Florida, 34682-2366, and the mailing address of the corporation shall be the same.

**ARTICLE IV**

- a. This corporation is a not for profit corporation and is organized to engage and operate exclusively in religious, charitable and educational activities within the meaning of Section 501(c)(3) of the United States Internal Revenue Code of 1954, as amended.
- b. No part of the net earnings of this corporation shall inure to the benefit of any member, trustee or officer of this corporation, or to any private individual (except that reasonable compensation may be paid for services rendered to or for this corporation in furtherance of one or more of its purposes).
- c. No substantial part of the activities of this corporation shall be the carrying on

of propaganda or other attempts to influence legislation, and this corporation shall not participate in, or intervene in (including the publishing or distributing of statements) any political campaign on behalf of any candidate for public office.

d. Upon the dissolution of this corporation or the winding up of its affairs, the assets of the corporation shall be distributed exclusively to charitable, religious, scientific, literary, or educational organizations which would then qualify for the provisions of Section 501(c)(3) of the United States Internal Revenue Code of 1954, as amended, and no member, trustee or officer of this corporation, or private individual shall be entitled to share in the distribution of any of the assets.

#### ARTICLE V

The corporation's initial registered office and the corporation's initial registered agent at such address are as follows: LARRY HOLLIS, 17020 1st Street E., #215, N. Redington Beach, Florida, 33708.

#### ARTICLE VI

The affairs of the corporation shall be managed under the direction of the Board of Trustees, said Board to initially consist of six individuals. 


