Articles of Amendment to the Articles of Incorporation
For

Following Chapter 617, section 617.1006, of the Florida Statutes, Help M-E-O-W-T Cat Rescue of Florida, Inc. adopts these amendments to its articles of incorporation.


FIRST: ARTICLE III-PURPOSE IS AMENDED TO READ:

Article III - Purpose

Help M-E-O-W-T Cat Rescue of Florida, Inc. is organized exclusively for charitable purposes including the making of distributions to organizations that qualify as exempt organizations under 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

SECOND: This amendment was adopted December 9, 1999.

THIRD: This corporation does not have members; therefore, this amendment was adopted by the board of directors of HELP M-E-O-W-T CAT RESCUE OF FLORIDA, INC.
