

The name of the corporation is hereby changed to ST. PETERS COMMUNITY DEVELOPMENT CORPORATION.

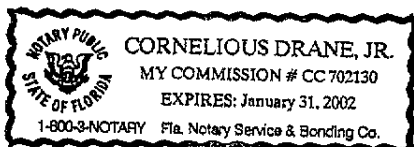
The Amended Articles were duly adopted by the Board of Directors, on April 18, 2000. There are no members entitled to vote on the Amendment to these Articles.
