A FLORIDA NONPROFIT CORPORATION**

**ARTICLE ONE
Name**

The name of the corporation is Mardi Gras Goodland, Inc.

**ARTICLE TWO
Principal Office and Address**

**ARTICLE THREE
Duration**

The term of the existence of the corporation is perpetual.

**ARTICLE FOUR
Purpose**

The purpose for which the corporation is organized is to conduct fund raising activities to benefit organizations exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Revenue Law. As a limitation, the purposes for which this organization is organized are exclusively religious, charitable, scientific, literary and education within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding provision of any United States Internal Revenue Law. The Corporation does not contemplate pecuniary gain or profit, incidental or otherwise notwithstanding any other provision of these Articles, this organization shall not carry on

any activities not permitted to be carried on by any organization exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding provisions of any future United States Internal Revenue Law.

ARTICLE FIVE Directors

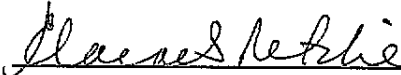
ARTICLE NINE
