ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act hereby adopt(s) the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation is the North Florida Lakes Organization, Inc.,

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III PURPOSE(S)

The specific purpose(s) for which the corporation is organized is (are):

The corporation is formed to request authorization from the Department of Environmental Protection to form Citizens Support Organizations (CSOs), and to address environmental concerns on state-owned lands, to acquire and direct volunteer labor, and to solicit donations and matching funds to further environmental enhancement of degraded state-owned sovereignty submerged lands, particularly in North Florida.

ARTICLE IV MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is:

The corporation's directors are elected from the general membership of its participating CSOs. The undersigned registered agent, Bruce M. Deterding, is named Corporate Director initially in order to accomplish the organization set-up of the CSOs. At such point as the corporation has 50 or more subscribers/members, an election will be held, with each subscriber/member having a single vote, to elect a board of directors comprised of six subscriber/members. The board will, in turn, elect a chairperson to preside over meetings of the board.

Nominations for the board of directors will be made by the board's chairperson, or the Corporate Director, with the advice and counsel of any subscriber/member.

The manner of elections are as stated in the bylaws.


