## **ARTICLES OF INCORPORATION**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not For Profit Corporation Act,, hereby adopts the following Articles of Incorporations.

### **ARTICLE I - NAME**

The name of the corporation shall be: Daytona Beach Flying Club, Inc.

### **ARTICLE II - PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be:

### **ARTICLE III - PURPOSE**

The specific purpose for which the corporation is organized is to provide efficient, low cost flying for the personal aeronautical education, recreation and pleasure of the members.

### **ARTICLE IV - MANNER OF ELECTION OF DIRECTORS**

The manner in which the directors are elected or appointed is by majority vote of all of the stockholders at the annual meeting of the corporation. This Corporation shall have three directors initially. The number of directors may be increased or decreased from time to time by the Bylaws adopted by the stockholders, but shall never be less than one. The initial directors shall hold office for the first year of existence of this Corporation or until their successors are elected and have qualified according to the Bylaws adopted by the stockholders, whichever occurs first.
