Articles of Incorporation

ARTICLE I: The name of this corporation is GOD's MANNA INC.

ARTICLE II: The principal place of business and mailing address are:

340 S. Woodland Ave., Deland, FL 32720

ARTICLE III: The specific purpose of this corporation is to further the Gospel of the Lord Jesus Christ, and to engage in any lawful act or activity for which corporations may be organized under the Nonprofit Religious Corporation of the State of Florida. This corporation is organized and operated exclusively for religious purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501© (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 © (3) of the Internal Revenue Code, or corresponding section of any future tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

BY LAWS
of
God's Manna Inc.

1. This church is and shall be known as God's Manna Inc.
2. Membership- The members of this corporation shall be those who have complied with the requirements set forth in section 2.2 of these by laws, who have properly applied for membership and who are inscribed on the Membership Roll of the Church.

Section 2.2-Requirements for Membership- Confession that Jesus is Lord, Baptism, Christian Experience.

Section 2.3-Removal of Members. Membership of any shall end on the occurrence of any of the following: Members resignation from the Church, the determination of the Church Council that the member should be removed from the membership.

3. General Offices- The general offices of the church are & shall be designated as the Church Council to include the trustees and to be named Ministry Leaders.
4. Compensation-Salaries, wages, together with fringe benefits or other forms of compensation (housing, transportation, and other allowances) paid to or provided for employees, directors, or officers will not exceed a value which is reasonable and commensurate with the duties and working hours associated with such employment and with the compensation ordinarily paid persons with similar positions and duties. Compensated individuals will not be allowed to vote on decisions concerning their own compensation nor will persons related to them.
5. Limitation & Authority for the Expenditure of Church Funds.
No church member, officer, committee or department shall incur financial obligations for the Church unless approved by the Church Council.
