ARTICLE I - NAME

The name of this corporation is THE NEW CHURCH AT BOYNTON BEACH PROPERTIES, INC., A FLORIDA NON-PROFIT CORPORATION

ARTICLE II - PURPOSE

The purpose of the corporation is to own and hold title to property which may be used to carry out the purposes of The New Church at Boynton Beach, Inc. and such other purposes allowed by Section 501(c)(3) of the Internal Revenue Code.

ARTICLE III - DURATION

This corporation shall have perpetual existence.
