**ARTICLES OF AMENDMENT
TO ARTICLES OF INCORPORATION
OF
AGGARWAL & GUPTA FAMILY FOUNDATION, INC.**

Pursuant to the provisions of Section 617.1006 of the Florida Statutes, the undersigned Florida corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation is Aggarwal & Gupta Family Foundation, Inc. (hereinafter referred to as the "Corporation").

ARTICLE II - TEXT OF AMENDMENTS

Article III of the Articles of Incorporation is amended by replacing it in its entirety with the following:

The Corporation has no members entitled to vote on the amendment. The amendment was adopted by the Board of Directors of the Corporation at a meeting held on November 5, 2024.


ARTICLE IV - EFFECTIVE DATE OF AMENDMENT
