Dear Optimist:

In compliance with Policy IC-7 and IC-35, the charter of your club has been revoked due to non-payment of dues. The effective date of revocation is September 30, 2004.

All statutes and regulations must be followed in the dissolution of the club and disposition of its assets. Club property or equipment bearing the name, insignia, or slogan of the organization should be donated to another Optimist Club or destroyed since the right to use terminates with the revocation of the charter.

The club's incorporation must be legally terminated under the statutes governing it. If applicable, the Secretary of State's office at the state capitol should be informed of the club's dissolution. The club's federal ID number will be given when the regional IRS office is informed of the charter revocation. Optimist International and its districts have no jurisdiction or rights relative to the disposition of club assets.

For your information, the Optimist International Foundation is a corporation qualified to receive any such assets.

The club may appeal the revocation decision by filing a written appeal within 30 days. If you plan to file an appeal, please call me at the phone number on the letterhead for a brief outline of the procedures (IC-35) that must be followed.

We trust that you will recognize the responsibility in settling all club indebtedness, including any outstanding dues.
