ARTICLES OF INCORPORATION
OF DI - GIORGIO SALON GROUP, INC.

ARTICLE I - NAME

The name of the corporation is DI - GIORGIO SALON GROUP, INC.

ARTICLE II - DURATION

The corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III - PURPOSE


