ARTICLES OF INCORPORATION

I, the undesigned subscriber to these Articles of Incorporation a being a person competent to contract, hereby associate myself for the purpose of becoming a corporation under the laws of the State of Florida providing for the formation, liability, rights, privileges, and immunities of corporations for profit.
