The undersigned, an individual, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Florida Business Corporation Act.

FIRST: The corporate name for the corporation (hereinafter called the "corporation") is Insight Strategies, Inc.

SECOND: The street address, wherever located, of the principal office of the corporation is 6719 Winkler Road, Suite 120, Fort Myers, Florida 33919. The mailing address for the corporation is the same.

THIRD: The number of shares that the corporation is authorized to issue is 1000 (one thousand), all of which are a par value of 1 (one) dollar each and are of the same class and are Common shares.
